Ensure Equal Opportunity and Affirmatively Further Fair Housing including the following: Market GHA’s tenant programs widely in the community to promote the programs to all races and ethnicities, regularly monitor GHA’s waiting list to ensure diversity, improve GHA website that is user friendly and which provides pertinent information and forms for public housing and programs.</p> <p>D.) Continue to fund renewable energy opportunities, including solar and thermal technology at all Asset Management Projects, and cut overall energy costs and consumption by 1/3.</p> <p>E.) Establish Income Targeting and Working Families occupancy and waiting list preferences to encourage de-concentration and income mixing of tenant residents at DuBois Garden Project.</p> <p>F.) Fund a rehabilitation conversion project at DuBois Garden to de-densify larger five bedroom units to single or two-persons occupancy units to better meet local housing needs for single persons and small families.</p> <p>G.) Continue to improve the rent collection process and improve overall tenant/staff security and financial accountability.</p> <p>H.) GHA will pursue the opportunity of a RAD conversion of its DuBois Garden 85-unit complex to a PBV program under the ownership of the housing authority.</p>
